President's Report

Mr. Bulger welcomed everyone to the meeting and reported on upcoming end of the year events, including Prom and Students Against Destructive Decisions (SADD) mock crash. He added that Commencement will be held on May 31st at 7:00 PM at the William V. Campbell Athletic Field.

He noted that as of April 24th of last year, enrollment is up 15 students and charter student enrollment is down 9 students.

The Allegheny Intermediate Unit (AIU) had their election and Mr. Bulger was elected to his 3rd term.

Superintendent's Report

Mr. Wehrer reported that the National Honor Society Induction Ceremony is going to be held on Friday, April 28th at 1:30 PM in the Senior High School auditorium.

The Griffin Awards will be on Thursday, May 4th and 1988 Steel Valley graduate; Harriet Freeman Jackson is going to be the guest speaker.

Middle School play, "A Wrinkle in Time" will run from May 18th – May 20th.

Assistant Superintendent's Report

Mr. Macuga started his report with a reminder that the Pennsylvania System of School Assessment (PSSA) testing dates for Barrett, Park and Middle School will be May 1st and 2nd for math and grades 4 and 8 only will have science on May 4th and 5th.

During the Math assessment, Steel Valley Middle School will have an early release at 1:07 PM. Park and Barrett Elementary Schools will be operating on regular schedules during the PSSA math assessments.

Keystone Exam testing for Steel Valley High School: May 16th will be Algebra; May 17th will be Literature; and May 18th will be Biology. Information related to the Keystone Exams will be sent home to families before May 1st.

Director of Pupil Services' Report

Mrs. Kozusko reported that the school district offered crisis prevention and de-escalation training to staff members during professional development opportunities on March 24th and April 5th. On March 24th, fifteen (15) paraprofessionals received training to assist them in keeping up-to-date on verbal de-escalation methods and physical intervention techniques. On April 5th, nineteen (19) special education teachers and four (4) paraprofessionals received this training. Staff require training each calendar year to maintain their certification in Crisis Prevention Institute's Nonviolent Crisis Intervention Training. Training activities will be planned for additional staff during the 2023-24 school year.

The school district's Special Education Plan is currently being completed for the years 2023-2026. Each school district in Pennsylvania is required to complete a special education plan every 3 years that describes the special education program and services that are provided within the district as well as programs and services outside of the district buildings that are provided to students based on higher levels of need. The school district's special education plan will be available on the district's website in draft form for public view and comment within the next couple days.

- 2.2 Board to authorize district officials to execute the Memorandum of Understanding between the school district and the local police departments, effective for the 2023-2024 and 2024-2025 school years.
- 2.3 Board to approve the purchase of a Double Stack Convection Steamer for the High School cafeteria kitchen for \$24,619.00 and a Double Stack Convection Oven for Park Elementary cafeteria kitchen for \$8,407.00, funded through the State Funds and Equipment Grant awarded to the district in February 2023. These items do not have to be bid upon or quoted because they are part of the COSTARS program.
- 2.4 Board to approve that the Steel Valley School District Board of Education fully supports the Resolution in support of Senate Bill 180 and House Bill 180 (SB180 and HB180) School Meals for All, so that all kids throughout the state of Pennsylvania can receive the food they need to be successful in school and further work to remove the stigma that has always existed in the school meals program.

4.0 Special Assignments

Mrs. Karstetter reported on specific events for the Steel Center for Career and Technical Education students. On March 8th they held "Discovery Day". Over 300 prospective students and their families explored Steel Center's 18 programs. As of the end of March, Steel Center received 500 new student applications.

May 9th is the National Technical Honor Society's (NTHS) final Vitalant Blood Drive as well as the NTHS induction ceremony. NTHS also partnered with the Veterinary Assistant program in April to hold a school-wide animal supply and food drive that will benefit Humane Animal Rescue.

5.0 Educational Leadership

 Education Plans (IEPs) for ESY eligible students. The program will run from July 3 through July 27, 2023.
- 5.2 Board to approve the School-Based ACCESS Program (SBAP) Support Services Agreement for the 2023-2024 school year for the Allegheny Intermediate Unit to provide support and assistance to the District in seeking reimbursement under Pennsylvania's School-Based ACCESS Program for certain health services provided by the District to its students.
- 5.3 Board to approve the Waterfront Learning Services Addendum to the Allegheny Intermediate Unit Services Agreement 2022-2023 so virtual educational services can be provided to one student for the remainder of the 2022-2023 school year at a cost of approximately \$3,820.

- 7.3 Board to approve the list of Supplemental positions for the 2022-2023 school year.
- 7.4 Board to approve Lauren Byers as a day-to-day substitute teacher for the remainder of the 2022-2023 school year at the approved daily rate of \$150.00 per day, effective May 15, 2023, clearances and pre-employment screenings are on file.
- 7.5 Board to approve the elimination of the Secondary Academic Math Coach position, retroactive to the beginning of the 2022-2023 school year, and the elimination of the Secondary Academic Literacy Coach position, effective at the end of the 2022-2023 school year.
- 7.6 Board to approve the temporary employment of six (6) student workers from the Steel Valley School District at the rate of \$10.00 per hour to assist the district personnel in preparing the district for the 2023-2024 school year, from June 12, 2023, to August 11, 2023.
