President's Comments

- The Board elected Mr. Joseph Bonacorso to serve as President and Mrs. Rose Marie Bartko to serve as Vice President of the Board of School Directors for 2003.
- Mr. Bonacorso thanked Mr. O'Toole for his two years as President of the School Board. During his
 tenure as President, the Board accomplished many goals, entered into a new collective bargaining
